ATTENTION IS DRAWN TO RULE 3(b)(iii)

“Any player who plays in a Cheshire FA Senior Cup Competition game shall become ineligible to play in the Cheshire FA Amateur Cup Competition in the current season”.

Rule 3(a)(iv)

Your attention is drawn to the provisions of the above rule relating to players requiring International Clearance.

Rule 9

Your attention is drawn to Rule 9 concerning the exchange of “list of players” prior to the game,

and the need to retain the list for 56 days after the game.

Rule 11

THE HOME CLUB, must confirm the fixture, choice of colours and location of their ground to their opponents and the MATCH OFFICIALS IN WRITING at least seven days before the game. Failure to comply will result in a fine of £15.00 being imposed.

NOTES

Extra Time, if required must be played in all games. If still a draw after extra time, the game will be replayed on Saturday 1st November 2008 subject to the provisions of Rule 14c. If a draw after extra time in the replay, the game will be decided by the taking of penalty kicks from the penalty mark, in accordance with the procedure adopted by the International Football Association Board.

OFFICIALS FEES Referee: £20.00, Assistants: £14.00 plus 27 pence per mile travel Allowance (*actually incurred*) if travelling by car. (All Fees payable by the Home Club).

ADVISE OF RESULT(Rule 14)

The result of the match **MUST** be telephoned to the Competition Secretary (0151 – 652 – 7422) by the HOME CLUB, IMMEDIATELY THE MATCH IS OVER.

COMPETITION RULES

The Competition Rules are provided in the 2008/2009 edition of the County F.A. Handbook, and it is the responsibility of Club Secretary`s to study these rules, and ensure that they are complied with, for failure to do so, may result in a financial penalty, or expulsion from the Competition.

SPECIAL NOTE: PLAYER QUALIFICATION – RULE 3(a)

YOUR ATTENTION IS DRAWN TO THE FOLLOWING:

- (i) Contract players are not allowed to play in this competition. In all rounds of the Competition prior to the Final, a player must be a registered player of his Club.
- (ii) Any such registration for the Amateur Cup must have been received and accepted by the League in which his Club competes, by 12 noon on the Friday previous to the date fixed for the playing of the round and the registration must be continuous through to the date of the match.
- (iii) In order to be eligible to play in the Final tie, players must have been eligible to play in the Semi-Final ties.

MATCH OFFICIALS – PLEASE NOTE BLACK UNIFORMS ONLY TO BE WORN

- (A) Match Officials must confirm their appointment within 3 DAYS of receipt to Jeff Walton, Honorary Referee Appointments Officer, preferably by email to: jeff.walton@cheshirefa.com or by returning the enclosed Card by first class post to Jeff Walton, `Dingleside`, 42 Rectory Lane, Lymm, Cheshire WA13 0AL or by fax to: 01925 757131.

In the event of any Match Official becoming unavailable, the Official **MUST** inform Jeff Walton on 01925 751981 IMMEDIATELY.

- (B) Report any contravention of the Competition Rules, to the Competition Secretary, in writing, within 72 hours(Sunday not included).

- (B) Must note that they will be required to officiate in any postponed game, unless given notice to the contrary.

- (C) Match Officials marked (*) or (+) are expected to travel all or part of the journey together at one expense. Officials should seek permission of the Referee Appointments Officer, or Competition Secretary, if possible, before travelling on his/her own.

SPECIAL NOTICE TO HOME CLUB AND MATCH OFFICIALS – COMPETITION RULE 6(a)

YOUR ATTENTION IS DRAWN TO COMPETITION RULE 6(a), WHICH REFERS TO THE COMPLETE ENCLOSING OF THE PLAYING AREA, BY FIXED BARRIER OR ROPE MATERIAL OF NOT LESS THE 8MM or 3/8TH OF AN INCH, IN DIAMETER.

THIS RULE MUST BE STRICTLY ENFORCED, AND MATCH OFFICIALS ARE ADVISED THAT THEY MUST NOT COMMENCE AND GAME UNTIL THE REQUIREMENTS OF THIS RULE HAVE BEEN SATISFIED.

HOME CLUBS ARE RESPONSIBLE FOR ENSURING THAT THE RULE IS FULLY COMPLIED WITH, (NOTING THAT TAPE IS NOT ACCEPTABLE), AND ARE ADVISED THAT THEY WILL BE FINED AND REMOVED FROM THE COMPETITION IN ACCORDANCE WITH THE PROVISIONS OF THE RULE.
